## BAND INSTRUMENT LEASE TO LEARN AGREEMENT

The above instrument is the property of WHITE HOUSE OF MUSIC, INC. and is leased to the undersigned.

**PURCHASE -** At any time during the term of this lease, or at the termination, you may elect to buy a new or used instrument. If you purchase a student-level instrument of the same type as those available in the White House of Music Lease to Learn Program, you will receive a 40% discount off the manufacturer list price. This discount may not be used in conjunction with other discounts or special sale prices. This leased instrument is not sold.

**TERM -** The term of this lease shall be for a minimum of three months and then charged to your credit card, debit card or checking account on a month to month basis, automatically renewed each month until terminated by either party upon 7 days notice.

**Delinquency charge:** 5% of any payment not received on or before the 10th day after its due date or \$5.00, whichever is less.

**RETURN -** To avoid a further monthly lease payment, customer must notify WHITE HOUSE OF MUSIC, INC. of the termination of the lease and permit them to take possession of the instrument prior to the expiration date.

In the event this instrument is not returned as required or is damaged beyond repair, undersigned agrees to pay a sum equal to 70% of the published list price of the instrument, regardless of the age or previous condition of the leased instrument. In all cases, the decision of WHITE HOUSE OF MUSIC shall be final.

**DEFAULT -** Upon default by customer, WHITE HOUSE OF MUSIC, INC. shall be entitled immediately to recover possession of the instrument and customer shall pay WHITE HOUSE OF MUSIC, INC. costs, including reasonable attorneys fees incurred in enforcing its rights hereunder.

If the undersigned moves from the address shown, WHITE HOUSE OF MUSIC will be advised promptly and shall have the option to cancel this agreement.

## **COMPREHENSIVE MAINTENANCE AND REPAIR PLAN**

### **REPAIR**

Damage to the instrument will be repaired at no additional cost. In the event of total destruction of the instrument or loss due to fire or theft, the lessee is responsible for 70% of the retail value. The lessor will accept this total, less the deductible portion of the lessee's household insurance, as payment in full. The lessee must present proof of insurance and report the theft to the police within 24 hours.

#### **\*Clarinets & Oboes**

1. replacement of necessary pads, corks, springs, etc. Broken mouthpiece coverage – 50%.
2. regulations of mechanism and leak-check
3. silver-solder any broken keys
4. free any frozen rods

#### **\*Wooden Clarinets**

5. in addition to previously-mentioned procedures all cracks in body of instrument will be filled and/or pinned and joint & bell rings will be tightened.

#### **\*French Horns**

1. re-string and regulate rotary valves
2. pulling frozen mouthpieces
3. freeing all frozen slides
4. silver-solder all broken or loose braces
5. replace necessary springs and felts
6. dents in bell and lead pipe to first solder joint.

### **MAINTENANCE**

All adjustments\* and repairs will be made to keep the instrument in proper playing condition. Does not cover expendable materials.

#### **\*Flutes**

1. replacement of necessary pads, corks, springs and etc.
2. regulation of mechanism and leak-check
3. silver solder all broken keys
4. free any frozen rods

#### **\*Saxophones**

1. replacement of necessary pads, corks, springs etc. Broken mouthpiece coverage – 50%.
2. regulation of mechanism and leak-check
3. silver-solder any broken keys
4. free any frozen rods

#### **\*Trumpets, Cornets & Baritones**

1. replacement of waterkey and valve corks
2. pulling frozen mouthpieces
3. freeing all frozen slides
4. silver solder broken or loose braces
5. replacement of necessary springs, felts
6. clean, buff, oil, and regulate pistons and slides
7. dents in bell and lead pipe to first solder joint.

#### **\*Drums**

1. Everything except sticks

#### **\*Trombones**

1. replacement of waterkey corks
2. pulling frozen mouthpieces
3. freeing all frozen slides
4. remove dents, clean and align playing slide
5. silver-solder all broken or loose braces

(coverage does not include restoration of finish and replacement of any expendable items)
